



## **Lighthouse Consulting and Initiatives (LHCI) Leadership & Adventure Camp Terms and Conditions**

### **1. Eligibility**

- The camp is open to participants aged between **11 to 16 years**.
- Participants must be physically fit and mentally prepared to engage in outdoor and adventure-based activities.
- Any medical conditions must be disclosed prior to participation.

### **2. Registration and Fees**

- Registration will be confirmed only upon receipt of the full/partial payment of ₹ 1500.
- Fees once paid are non-refundable/partially refundable (see below for cancellation policy).
- LHCI reserves the right to cancel, postpone, or reschedule the program due to unforeseen circumstances such as weather conditions, safety concerns, or operational reasons. In such cases, suitable alternatives or adjustments will be communicated.
- Parents who are planning to stay over along with the child will have to pay Rs. 1,500.

### **3. Code of Conduct**

Participants are expected to:

- Follow all instructions given by trainers, facilitators, and support staff.
- Maintain discipline, respect, and teamwork throughout the program.
- Refrain from any behavior that may cause harm to themselves, others, or the environment.
- Avoid carrying or using prohibited items such as sharp objects, substances, or restricted electronic gadgets.

LHCI reserves the right to remove any participant from the camp for misconduct without refund.

### **4. Medical Fitness and Declaration**

- Participants must be medically fit to take part in physical and outdoor activities.
- Any pre-existing medical conditions, allergies, injuries, or medications must be disclosed in advance.
- LHCI will take reasonable precautions but will not be held responsible for issues arising from undisclosed medical conditions.

- In case of emergency, LHCI is authorized to administer first aid and seek professional medical assistance if required.

## **5. Risk Acknowledgement**

- Adventure and outdoor activities involve inherent risks including but not limited to physical exertion, minor injuries, environmental exposure, and unpredictable conditions.
- Participation is voluntary, and these risks are acknowledged and accepted.

## **6. Safety Protocols**

- All activities will be conducted under the supervision of trained facilitators.
- Safety guidelines and instructions must be strictly followed at all times.
- Required safety equipment will be provided and must be used as instructed.

## **7. Transportation**

- Transportation arrangements will have to be made at the participant's end for arrival and departure from the reporting point.
- LHCI will take reasonable care during transit but is not liable for delays, disruptions, or circumstances beyond control.

## **8. Food and Accommodation**

- Details regarding food and accommodation will be shared prior to the program.
- Participants must inform any dietary restrictions or allergies in advance.

## **9. Use of Media**

- LHCI may capture photographs and videos during the camp for documentation, training, and promotional purposes.
- Participation in the program implies consent for such usage unless otherwise specified in writing.

## **10. Personal Belongings**

- Participants are advised not to carry valuables.
- LHCI shall not be responsible for any loss, theft, or damage to personal belongings.

## **11. Liability**

- LHCI, its trainers, staff, and associates shall not be held liable for any injury, loss, or damage incurred during the program due to participant negligence, non-compliance with instructions, or unforeseen circumstances.

## **12. Cancellation / Withdrawal Policy**

- Cancellation made 7 days or more prior to the program will attract a deduction of ₹500 from the total fee.
- Cancellation made within 2 to 7 days prior to the program will attract a deduction of ₹1,000 from the total fee.
- Cancellation made less than 2 days prior to the program or just before the event will attract a deduction of ₹1,500 from the total fee.
- No-show on the day of the program will result in no refund.

**LHCI Credit Carry Forward Policy:**

- If opting for this policy, the applicable cancellation cases, 50% of the deducted cancellation charges, along with any eligible refund balance, will be retained as a credit with LHCI.
- This credit can be utilized for participation in future LHCI programs/events, subject to validity of 12 months and applicable terms.

**13. Amendments**

- LHCI reserves the right to modify these terms and conditions at any time. Any changes will be communicated appropriately.

**14. Acceptance of Terms**

- Enrollment in the program implies acceptance of all the above terms and conditions.
